Please refer to herewith enclose the copy of Times of India newspaper cutting dated 30th January, 2019 in which fraud of 97000 crores by M/s. DHFL has been reported wherein name of M/s. Sahana Groups and its eleven companies was also mentioned.

Sir, as far as our Milansar Society Rehab building is concerned, SRA had not yet done any allotment and possessions of shops are not being given to anybody till date. Further we have learnt that offices of 4 dubious companies had been shown in shop no.02, 03, 04 & 05 which never existed in our Milansar C.H.S. rehab building, but to cover-up the fraud reported in times of India 30th January 2019 edition the men of M/s. Sahana Groups are trying to take forcible possession of these four shops in our rehab building. (herewith enclosed are the names of those four companies obtained from internet.)

Sir, Milansar C.H.S. Ltd., is redeveloped under slum rehabilitation scheme by M/s. Safehome Developer & Contractors and its partners Mr. Wahid Khatri & Mr. Aziz

Qureshi and according to Slum Act or SRA provisions scheme cannot be sold or transfer to any other builder no third party rights can ever be created. Hence M/s. Sahana Groups or its any other companies has no right over said building or its shops.

So, it is hereby requested any attempt to take forcible possessions of shops in our building must be legally opposed by our residents & society members I request your kindness that no undue favour to cover-up fraud by the shell companies to be given if they tries to seek police protection without hearing Milansar C.H.S. Ltd. side.

Hope you will do the needful favourably so law & order prevails in our society and locality.
